The Koru's policies for the governance of the Hokorian State (2025 to 2026)

May 2025 to June 2026

Introduction

It's important that the Hokorian State is able to develop itself as a nation, whilst allowing the people to have a say in it's Governance. This is why Their Majesty's Office (the Koru's Office) is establishing it's policy.

The Koru's Office is working to become impartial- working only for national benefit and not for any political party. These policies extend to Their Majesty's Government and the Hokorian Assembly as policies that the Koru's Office will work to ensure are fulfilled, whilst continuing to allow the elected Government and Councillors to create their own policies to coincide with the Koru's policies.

These policies focus on key areas of national development (physical, digital and financial), the rights of nationals, as well as democracy and engagement. They will be in place from publication until the 1st June 2026.

Developing as a nation

Digital services

- The Government will work to ensure that all Government organisations publish information and news to hokoriagov.net, making this information archivable and publicly accessible for the purposes of transparency and evidencing the fulfilment of duties.
- The Government will work to introduce legislation that protects the information and private data held by the Government of Hokorians and foreigners.
- The Government will work to ensure that public services are introduced to allow Hokorians and foreigners to better access, amend and request removal of their information.
- The Government will work to ensure that all public services and forms are accessible both digitally and traditionally by the completion of a paper form, and will launch a support team for assisting Hokorians and foreigners with the completion of forms and using services.

Financial growth

- The Government will work to introduce legislation that allows Hokorians and foreigners to establish or register businesses and organisations within the Hokorian State, as well as regulations to ensure that businesses and organisations follow good practices.
- The Government will work to introduce legislation that protects work through copyrighting, trademarking and patenting.
- The Koru's Office will work with the Government to establish Their Majesty's Treasury, as well as legislation to require the regular publication of financial records of the Government.
- The Government will work to establish partnerships with Governments, businesses and organisations to increase and facilitate trade, whilst protecting businesses, organisations and consumers.
- The Government will work with international partners to establish a currency, or to use an existing currency.

Nationhood

- The Government will work to publish a detailed plan for acquiring complete control of land to govern and how it will initially govern this land.
- The Government will work to introduce legislation that brings the Hokorian State as line with the Vienna Convention on Diplomatic Relations and Geneva Conventions as much as possible.

Hokorian Forces

- The Koru's Office will work to establish the Hokorian Forces as an organ of the Hokorian State, which will be given the duties of providing healthcare, construction, defence, enforcement and protection services for the Hokorian State.
- The Koru's Office will work with the Government to introduce legislation that makes serving in the Hokorian Forces mandatory for Hokorians and to make Government service a part of mandatory service.

The rights of nationals

Passports and assistance

- The Government will work to produce Hokorian Passports in line with international standards to act as official identification and to allow for easy entry to nations and territories that accept Hokorian Passports.
- The Government will work to develop an assistance programme where Hokorians can get help with passports, get limited financial aid and be signposted to resources, as well as where foreigners can get help with nationality related queries.

Courts and trials

- The Koru's Office will work to establish Their Majesty's Courts, the Prosecutor's Office and a Legal Aid programme to develop a judicial system that's fair and efficient.
- The Government will work to introduce legislation that protects jurors, witnesses and victims of crime.

Democracy and engagement

Elections

- The Koru's Office will work with the Government and Assembly to introduce legislation that amends the Constitution to give greater power to the Assembly to change the way that elections work.
- The Koru's Office will work with the Government to make voting in elections and referendums easier and more secure.

Courts and trials

- The Koru's Office will work with the Assembly to introduce a public petitions service and committee to allow Hokersians to petition their Government.
- The Koru's Office will work with the Government to introduce a public consultations service to allow Hokersians to give their say on Government plans.
