This spending report is released in accordance with the Royal Office's commitments to transparency. The Royal Office's spending reports detail government borrowing, government debt, government spending and government earning for a specified period of time. Spending reports will also include estimations and comments by the Chancellor in regards to how any debt will be paid, as well as strategies to maintain earnings.

All amounts are in the Euro (EUR), converted from Pound Sterling (GBP) at the rate of 1.17 and US Dollars (USD) at the rate of 0.92. Euro (EUR) is used for official currency calculations and transactions within the State of Hokoria.
